U.S. Fish & Wildlife requires invoice, packing list original CITES permits and other U.S. or foreign permits. Also any veterinary or health certificates will benefit with the expediting of the release.

U.S. CBP Agriculture Services will review all entries of trophies to determine if any species are restricted. Restricted species must go to an APPROVED Taxidermist or Tannery to assure compliance with the Agriculture (USDA) regulations.
